PASADENA POLICE DEPARTMENT Vehicle Tow Information



The vehicle you were driving has been impounded by the Pasadena Police Department.

You have the right to take any loose personal items from the vehicle prior to its removal by the tow service. It is highly recommended that you do take personal items out of the vehicle.

Please take a moment to look at the impound form. Make sure that all Items left in the vehicle that you feel are valuable are listed on the form. If, at a later date, you try to report items stolen from the vehicle that are not on the impound form, keep in mind that your claim will be compared to the impound form.

Stereos and speakers or any other items that are attached to the vehicle must stay with the vehicle.

If the driver of the vehicle was unlicensed, or if the driver was driving the vehicle with a suspended or revoked license, the vehicle will be impounded for a minimum of 30 days. The vehicle can be released prior to the 30 days if the person driving the car at the time of the impound obtains a valid license. The law requires that the owner of the vehicle be responsible for anyone driving their vehicle and not allow their vehicle to be driven by an unlicensed driver or a driver with a suspended license. If you require a hearing to get your car out of impound or to the 30 days, contact the Traffic Office. Please review the criteria above for a vehicle to be released early. If you do not qualify, a ring will not result in an early release of your vehicle.

You will receive a Lien Sale notice in the mail from the tow service. It enables the tow service to sell your vehicle at the end of the thirty-day penod if you choose not to pick it up. They will not sell your car prior to the thirty days. It is your responsibility to contact the tow company prior to the end of the thirty days if you need more time to remove your car from impound. Your car will be lien sold AFTER 30 DAYS if they do not hear from you.

If you have any complaints about the way you were treated by the tow service, please contact the Traffic Office at (626) 744-4590.

If you have complaints about items missing from vehicles call the above contact person for the appropriate tow service. If the problem is with Master's and not resolved, call the Pasadena Police Department for a report (626) 744–4501. If the problem is with Freddie Mac's call the Los Angeles County Sheriff's Department for a report (626) 285-7171.
