

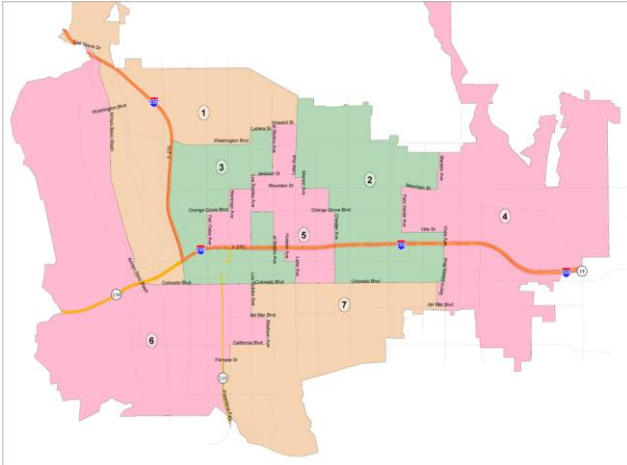


Notice of Public Hearing

PASADENA REDISTRICTING TASK FORCE

PROPOSED CITY COUNCIL REDISTRICTING MAP (MODIFIED)

Subject: Pursuant to Pasadena City Charter Section 1201, the City of Pasadena must modify the boundaries of the districts from which Councilmembers are elected following each decennial census so that such districts are as nearly equal in population as practicable. The **Redistricting Task Force** appointed by the City Council has completed the initial process of redistricting and endorsed a proposed map to change the boundaries of the districts ("Proposed Map"). At its February 15, 2012 meeting, the Task Force, following a public hearing, directed the consultant to prepare and present alternative(s) to the modified Proposed Map (shown below) at the March 7, 2012 meeting.



NOTICE IS HEREBY GIVEN that the **Redistricting Task Force** will hold a public hearing to receive public comment and to consider alternative(s) prepared by the consultant to the modified Proposed Map.
