BACKGROUND:

The Pasadena Unified School District held its Primary Nominating Election on March 8, 2005, for Board of Education Seats 1, 3, 5 and 7. At said Primary Nominating Election, Seat 1 candidate Mike Babcock, Seat 5 candidate Esteban (Steve) Lizardo, and Seat 7 candidate Ed Honowitz each received the majority of votes for their respective offices and were elected to the office of member of the Board of Education, Seats 1, 5 and 7, respectively.

In the March 8 Primary Nominating Election, in the Seat 3 race, no candidate received a majority of the total votes cast for the respective office. Pursuant to City Charter Sections 703 and 706, the names of candidates Susan Kane and Scott Phelps were printed on the General Election ballot for Seat 3.

The final tally of the votes cast for said candidates at the General Election on April 19, 2005, is as follows:
