

BACKGROUND:

The Pasadena Unified School District held its Primary Nominating Election on March 8, 2011, for Board of Education Seats 2, 4 and 6. At said Primary Nominating Election, Renatta Cooper, Board of Education Seat 2 candidate, and Kimberly Kenne, Board of Education Seat 4 candidate, received the majority of votes for said offices and were reelected and elected to their respective offices.

In the March 8th Primary Nominating Election, in the Seat 6 race, no candidate received a majority of the total votes cast for the office. Pursuant to City Charter Sections 703 and 706, the names of candidates Sean J. Baggett and Tom Selinske were printed on the General Election ballot for Seat 6.

The final tally of the votes cast at the General Election on April 19, 2011, is as follows:
