**A RESOLUTION OF THE PASADENA BOARD OF EDUCATION
DECLARING THE RESULTS OF THE
PASADENA UNIFIED SCHOOL DISTRICT
GENERAL ELECTION HELD TUESDAY, APRIL 16, 2013**

WHEREAS, the Pasadena Unified School District held a General Election on Tuesday, April 16, 2013, for Member of the Board of Education, District 3 (four-year term), as required by the Pasadena City Charter; and

WHEREAS, the votes at said election have been canvassed by the City Clerk, acting in his capacity as the Assistant Secretary to the Board of Education during the conduct of Board of Education elections, and a copy of said canvass is attached hereto as Exhibit A, and incorporated herein by reference; and

WHEREAS, said City Clerk has certified the results of said canvass to the Board of Education of the Pasadena Unified School District.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Pasadena Unified School District that:

1. The following be declared to be the results of said General Election:

FOR DISTRICT 3 (Full, four-year term)

Ruben Hueso	626 votes	(38.7%)
Tyron Hampton	993 votes	(61.3%)

2. That Tyron Hampton, having received a majority of the total votes cast for candidates for the office of Member of the Board of Education, District 3, from which the candidate sought nomination, hereby is declared elected as Member of the Board of Education, District 3


