



# BANNER PERMITS

## REQUIREMENTS FOR HANGING BANNERS IN THE CITY OF PASADENA:

- Banners must pertain to a festival, spectacle or other civic event held in the City of Pasadena of a general civic and public nature as specified in Pasadena Municipal Code Chapter 12.15.
- Banners must list the start and end dates of the festival, spectacle or other civic event.
- Banner postings may not exceed 30 days unless authorized for extension.
- Sponsorship logos shall not exceed ¼ of the banner.
- Banners may be installed no sooner than 30 days prior to the beginning of the event.
- Banners must be removed no later than 5 days after the completion of the event
- Permits will be issued on a first-come, first-served basis and shall be valid for 30 days.
- All fees associated with installation, maintenance, and removal of banners shall be the responsibility of the applicant and/or permittee and paid prior to issuance of the permit.
- Banner permits will be approved based on the following priorities:
  - City sponsored
  - City co-sponsored
  - Event geographically within the City of Pasadena

### The Applicant is required to:

- Submit a completed Banner Application 30 days in advance of proposed installation.
- Submit for approval, a layout of the proposed banner including artwork and wording. It is recommended that banners not be ordered or purchased until approval from the City has been received.
- Provide Insurance per City of Pasadena requirements.
- See attached Drawing 4342 for approved side banner placement on city streetlight poles.
- Permits are valid for 30 days. Permits may be renewed on a first-come, first-served basis for an additional 30 days based on the availability of streetlight poles. Permittee shall submit a renewal application for consideration.

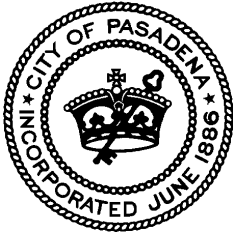

### General constraints:

- Banners may be installed on arterial streets with commercial and business frontages.
- No banner installations in front of Ruznak dealership (267 W. Colorado Blvd.).
- No banner installations on bridges or freeway overpasses.
- No installations on residential streets. See City of Pasadena zoning map for reference.
- No installation in the following areas without written authorization: (1) within the Playhouse District; (2) near Memorial Park - Raymond Ave from Holly St to Walnut St and Walnut St east of Raymond Ave; and (3) East Washington Blvd from Hill Ave to Allen Ave.
- Traffic control per latest edition of California Manual on Uniform Traffic Control Devices.
- No lane closures on arterial streets between 7-9 am and 4-6 pm.

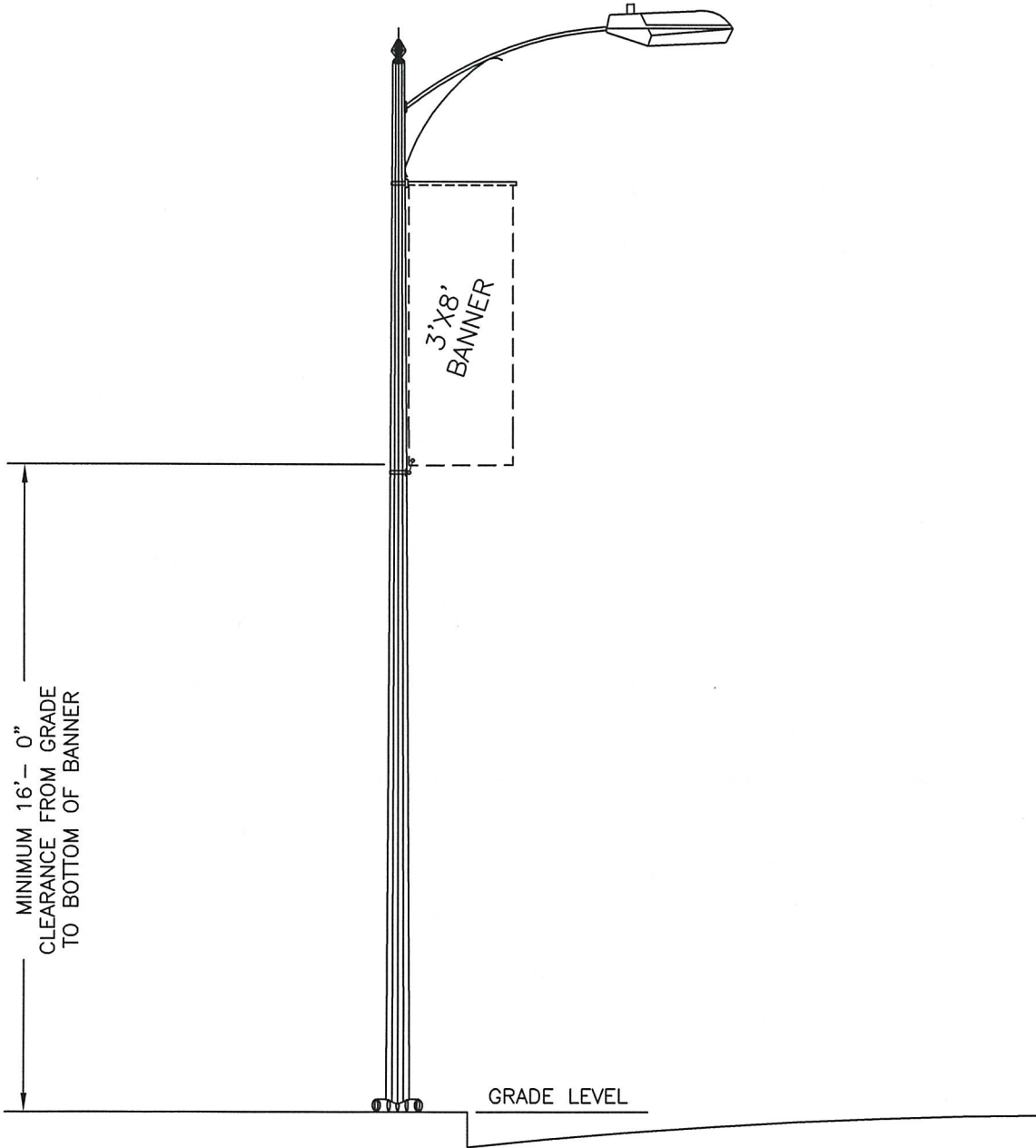
